# THE LARGEST FRENCH PETITION EVER GOT OVER 1,5 M SIGNATURES AGAINST DUPLOMB LAW

## LEGISLATIVE VOTE & AGRICULTURAL STAKES

**USPA NEWS** - On 8 July 2025, the National Assembly passed the Duplomb bill, sponsored by Senators Laurent Duplomb (LR, THE REPUBLICANS) and Franck Menonville (UDI ), with 316 votes in favor and 223 against. The Senate had earlier approved it by a 70% majority. A conditional reintroduction of the neonicotinoid acetamiprid (banned since 2018 in France but still permitted elsewhere in the EU). Regulatory easing for large livestock facilities and irrigation reservoirs ("megabassines"). Supporters, including the FNSEA, (Largest French Agriculture Union) argue these levels the playing field with EU peers and protects crops like sugar beet from pests. The speed of the signature grew up so rapidly that by 20 July, it reached 1 million signatures, the first petition ever in the Fifth Republic to do so. Within three days, it surged to 1.5 million signatures, setting a new record.

According to the Assembly's petition portal, this is: "An unprecedented citizen mobilization in the history of the Fifth Republic". The petition overcame significant technical obstacles to reach over 1 million signatures, further building on the record-breaking 500,000 collected within days, surpassing the previous top petition (264,000 signatures on the BRAV M dissolution).

It underscores the massive societal rejection of this law. The statement outlines why the law faces such public wrath, not only It reintroduces neonicotinoid pesticides (e.g. acetamiprid), harmful to bees and biodiversity, but it also facilitates control over water resources by large farm and enables the development of megafarms, clashing with sustainable agriculture. However, critics argue the law was pushed through with no proper democratic debate or opportunities for parliamentary amendment.

## CIVIL SOCIETY GOALS & INSTITUTIONAL LEVERAGE

According to a few Environmental NGO Générations Futures urged French citizens to press on toward 1.5 million signatures to amplify the movement's impact. Their spokesperson François Veillerette called the petition a "tidal wave" against governmental environmental. The statement pleads directly to French President Macron, urging him to: Refuse to promulgate the Duplomb law. His feed-back is highly expected, while the French Prime Minister Francois Bayrou said he'll look at the case. This Launches a nationwide debate involving farmers, health professionals, ecologists, and citizens, to redefine sustainable agriculture rollbacks and tense oppositions, while the most population is on vacation and spread all over France enjoying their hot holidays (Sources: the Guardian, Public Senate TV Channel, L'Essentiel, Eco1)

## PUBLIC & SCIENTIFIC OUTRAGE

• NGOs like Greenpeace, POLLINIS, WWF France, and Generations Futures denounce the law as "poison legislation", succumbing

to agro-industrial lobbying over scientific and ecological interests

- Scientists, apiarists, medical associations, and cancer organizations cite serious risks to bees, human health, particularly neurological effects, and ecosystem stability, with cancer campaigner Fleur Breteau decrying lawmakers as "allies of cancer."

#### NEW STEPS IN THE DEMOCRATIC PROCESS

- A Constitutional Council review is expected by 10 August 2025 amidst challenges from left-wing deputies citing procedural flaws and environmental constitutional violation
- If upheld, the petition will lead to a parliamentary debate in September 2025, though the law itself won't be revoked through this process Sources ( TF1, Info, French Senate, Capitale Agglopolitics, Generations Futures)

Let's recap some events, and timeline, over Dulomb's bill

Date Event

8 July 2025 Duplomb law passed: 316–223 vote in Assembly

10 July 2025 Petition launched by E. Pattery

18 July 200,000+ signatures

19 July 500,000+ (debate threshold)

20 July 1 million+ signatures (historic record)

21 July 1.5 million+ signatures

Constitutional review due by 10 August

Parliamentary debate expected in September

The Duplomb law exemplifies a deep clash between agricultural policy and environmental health, with practices, such as pesticide use and large-scale farming, coming under scrutiny.

The record-breaking petition signals a powerful resurgence of citizen-led democratic expression in France's Fifth Republic. The forthcoming Constitutional review and parliamentary debate will critically test whether France balances economic interests with its environmental commitments and public health.

It is up now to either the French President Macron, the executive in chief to decide whether the petition matters, or if the French Prime Minister would grant the civil society to win against the bill already voted at the French Parliament, or the third option that could be left to the French Constitutional Council, to take the final decision over this petition diving the government into a political turmoil during a very already tense period....To be continued
